# Policy 25

 Intent: To encourage, promote and facilitate a new strategic approach to economic development that also provides a practical model for building a wellbeing economy

## Outcomes:

- local economic development that focuses on community and place benefits as a central and primary consideration
- support community ownership and management of buildings and land
- "Development proposals which contribute to local or regional community wealth building strategies and are consistent with local economic priorities will be supported".

# Housebuilding in support of CWB

- Policy 16b Development proposals that include 50 or more homes, and smaller developments if required by local policy or guidance, should be accompanied by a Statement of Community Benefit. The statement will explain the contribution of the proposed development to:
  - i. meeting local housing requirements, including affordable homes;
  - ii. providing or enhancing local infrastructure, facilities and services; and
  - iii. improving the residential amenity of the surrounding area
  - ... and community wealth building?
